MONTHLY FINANCIAL SUMMARY MALECARE, INC.

Fiscal Year 2022

HIGHLIGHTS

Malecare continued its upward revenue trend and experienced a very strong fiscal year 2022. Total revenue for the year ending December 31, 2022 more than doubled to \$1.02m from \$462k in 2021. This growth was driven by an increase in Corporate Contributions, which comprise 95% of total revenue.

As a result of this strong performance, cash has increased by \$840k since last year. The cash balance at December 31, 2022 is \$1.3m, which is 6.7x the total expenses for fiscal year 2022. This cash balance provides Malecare with enough cash to cover over 6 years of operating expenses at its current level of expenses.

As a note, these financial statements do not include an accrual for Wegner's fees, which may increase if Malecare is subject to an audit due to the increased revenue in 2022.

FINANCIAL REPORT DISCUSSIONS

Statement of Financial Position

Total Assets are \$1.3m, which increased by 160% from last year. This increase is primarily due to higher revenue received from Corporate Contributions. The majority of Total Assets, or 98%, are Cash and Cash Equivalents. Additionally, Malecare has virtually no liabilities.

Statement of Activities

Total Revenue increased by \$560k, or 121%, from the previous year. Corporate Contributions drove the increase, led by \$325k from Myovant Sciences, \$200k from Amgen, and \$190k from Merck.

Expenses decreased by 6% to \$194k from the previous year with salary and related expenses representing the

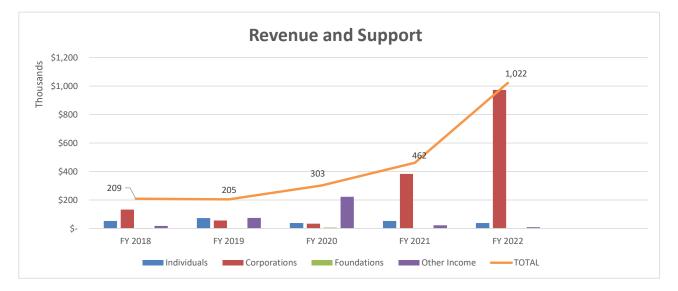

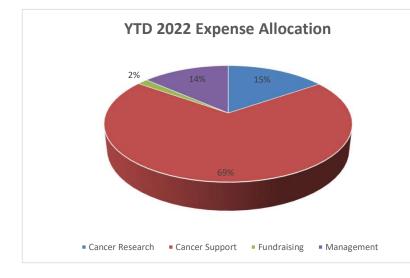
majority of expenses (\$145k or 75% of total expenses).

Program services continue to make up the largest share of expenses with 84% of the total. The remaining breakdown is 2% for fundraising and 14% for MG&A.

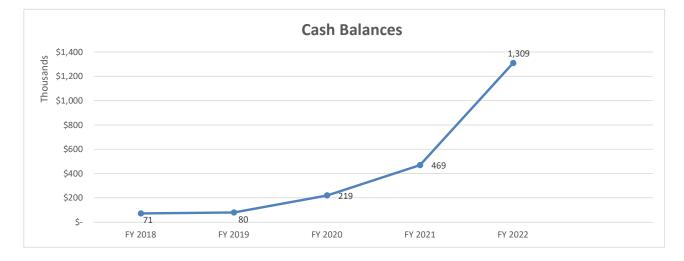
